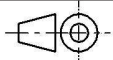

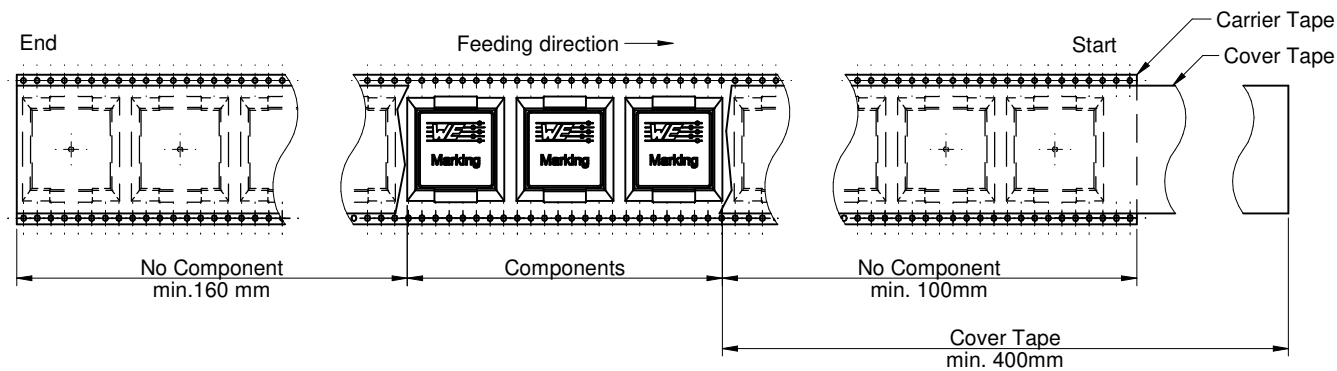

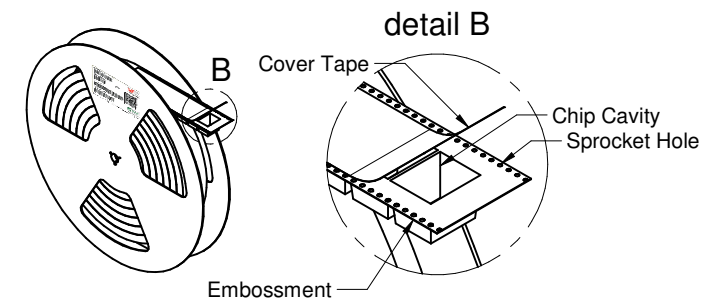
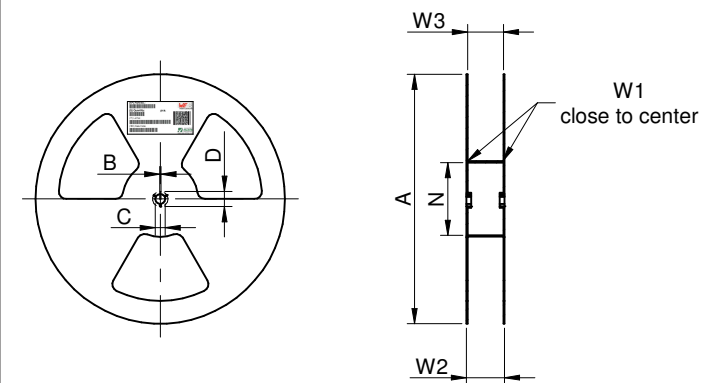

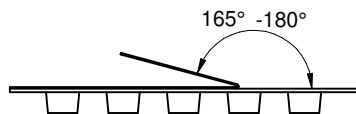

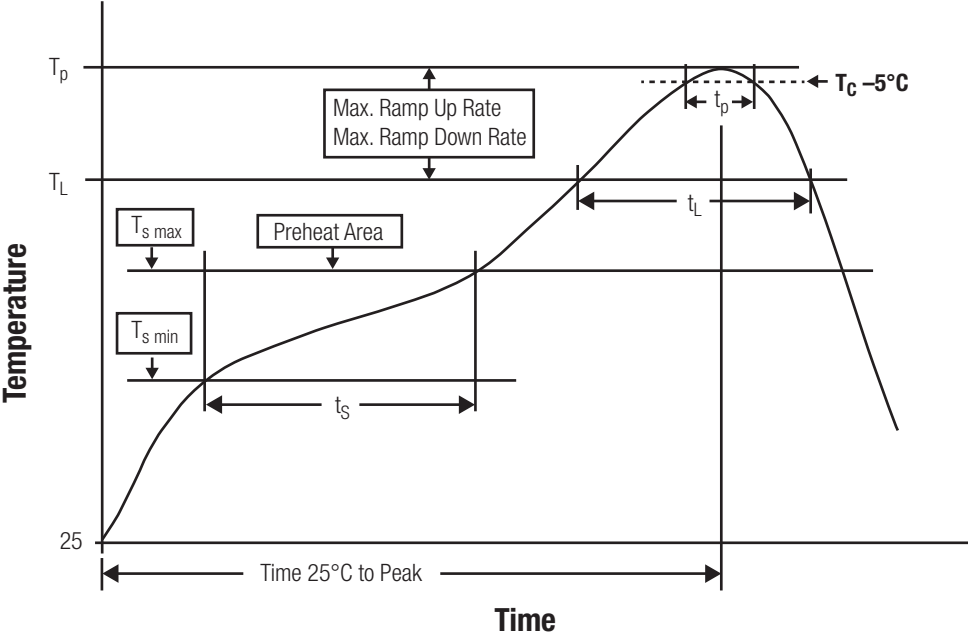

Soldering:

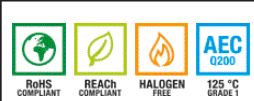
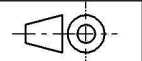
Packaging:

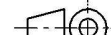
